**Dots:**

Supplier has been rejected by the evaluation committee based on the reasons below:

1. The Supplier has submitted the documents with the name of Dots but the company profile submitted with the name of Dots Concept SMC Pvt. Ltd.
2. Declaration of Eligibility is also submitted with the name of Dots Concept SMC Pvt. Ltd.
3. There are the separate registration of Dots and Dots Concept SMC Pvt. Ltd and cannot be considered as one company/entity.


**Team Work Technologies:**


Supplier has been rejected by the evaluation committee based on the reasons below:


1. According to the scoring criteria outlined in our ITB documents, a minimum passing score of 70 was required. The supplier Team work technologies have not obtained the required marks.
